MEMBERSHIP FORM

Membership Information

- Any individual, company, civil society or institution legally registered and currently operation
 within or outside Tanzania either directly or indirectly engaged or interested in furthering and
 strengthening commercial, individual, cultural and social ties between Switzerland and
 Tanzania shall be eligible for membership.
- The Board of Directors shall decide over applications for membership which shall be made in writing.
- Any member of the chamber shall express desire to resign/retire as a member and shall signify such desire in writing to the Executive Director and such person's shall be removed from the list of members and he-she shall there upon cease to be a member. Such notice shall be at least one month before the end of business year. There shall be no reimbursement of the fees paid for the membership.
- The Board of Directors may by a vote of at least three quarter of the Board temporarily suspend or permanently expel any member who violates these by-laws, any other rules of the chamber or for any other just reason after a member isgiven notice and opportunity for hearing before the Board of Directors
- Membership is valid for one full year starting from the date of the executed Membership Form.
- STCC informs the members 30 days prior to the expiration of the members' subscription
 if they wish to cancel their membership. If membership termination is notrequested, STCC
 will issue an invoice for the new membership year.
- If a member fails to settle the invoice for the new membership year at the expiration date, he is considered to be overdue. If the member shows no intention of paying, he will be suspended. If, by the end of the month following the expiration date, the member still hasn't paid and has not demonstrated any intent to do so, the STCC will revoke his membership status.
- Corporate members have the option to designate one or more individuals to represent their company at STCC meetings.
- The STCC operates under the principle of 'One Member One Vote'.
- The STCC expects all its members to utilize the platform in a constructive manner, actively contributing to economic growth, while abstaining from any unethical or anti-competitive practices.

Individual Membership

- Applies to individuals of good standing who are residing in Tanzania and who are actively involved in business, consultancy, trade, or investment in Tanzania.
- Individual membership is not available for those employed by companies who are applicable for corporate membership under the rules described above.

Out of Country Membership

 Applies to companies wishing to invest in Tanzania but not yet with physical presence in the country.
